

**ORDER**

In pursuance of Director, FCS&CA, Assam vide W.T. Message No. DS.58/2017/57 dated 28/07/2017, 1353.80 Qtls. of Rice for AAY Ration Card Holders and 6075.45 Qtls of Rice for Priority Ration Card Holders under National Food Security Act, 2013 for the month of September/2017 is hereby sub-allocated to the following nominees under Bokakhat Sub-Division. The last date of value deposit and lifting of Rice for the month of September/2017 is fixed on 31/08/2017. The allocation of Rice has been made @ 35.00 Kgs. to each AAY Ration Card Holder @ Rs.3/- per Kg. Per month and @5.00 Kgs. of rice to each member having Priority Ration Card @ Rs. 3/- per Kg. per month. Further it is also instructed that the Door Step Delivery of Food Grains to the beneficiaries is mandatory. The GPSS/FP Shop Dealers/Agents are also liable for punishment, if found guilty on the charge of realizing more than Rs. 3.00/- per Kg. of Rice.
